Re: Shelby Energy Cooperative's ("SEC") Case No. 2010-00244 Filing Deficiencies

Dear Mr. Derouen:

This letter contains Shelby Energy's ("SEC") response to a Commission deficiency letter dated July 27<sup>th</sup>, 2010 in regard to SEC's application for a Certificate of Public Convenience and Necessity ("CPCN") for its "2010 ~ 2014 Construction Work Plan"

(1) 807 KAR 5:001, Section 8(3) - If applicant is a corporation, a certified copy of its Articles of Incorporation and 'all amendments thereto, if any, shall be annexed to the application. If applicant's Articles of Incorporation and amendments thereto, if any, have already been filed with the Commission in some prior proceeding, it will be sufficient if this fact is stated in the application and reference is made to the style and case number of the prior proceeding.

## SEC's Response:

The style and case number of the referenced case as allowed in 807 KAR 5:001: Section 8(3) were indicated within the original application as "Item 3" and read as follows:

- "3. The Articles of Incorporation and all amendments thereto for the Applicant were filed in Case No. 97-231 of the Kentucky Public Service Commission and incorporated by reference herein. {807 KAR 5:001, Section 8(3)}"
- (2) 807 KAR 5:001, Section 9(2)(d) Three (3) maps to suitable scale (preferably not more than two (2) miles per inch) showing the location or route of the proposed new construction or extension, as well as the location to scale of any like facilities owned by others located anywhere within the map area with adequate identification as to the ownership of such other facilities

## SEC's Response:

The requested map will be submitted via electronic filling and (3) paper copies will be delivered to the Commission Filing Division. The maps will indicate the proposed new construction or extensions; please be advised that like facilities owned by others do not exist within conflicting distances from said proposed facilities. The request to indicate like facilities owned by others located "anywhere within the map area" is not obtainable as Shelby Energy does not have the facility maps from other electric utilities for the entire extent of the filed map.

All materials filed electronically in support of Case No. 2010-00244 are a true, accurate and complete representation of the original documents.

One (1) complete original response in paper form will be filed with the Commission pursuant to the guidelines for electronic filing.
