Dear Mr. DeRouen:

Time Warner Cable Information Services (Kentucky), LLC (“TWCIS”) submits this letter in response to the Commission’s May 30, 2012 Order in the above-captioned docket. That order directs “all affected parties” to provide certain information relating to their access tariffs, in the interest of assessing compliance with the reforms adopted in the Federal Communications Commission’s (“FCC’s”) order released on November 28, 2011 (FCC 11-161). Although TWCIS was not an access services provider in Kentucky when this case was established and was not a party to this proceeding, it provides this information out of an abundance of caution and in the interest of cooperating with the Commission’s efforts.

All of TWCIS’s voice telecommunications traffic is Voice-Over-Internet-Protocol (“VoIP”) traffic. Consistent with the FCC’s order and its implementing rules (*see* 47 C.F.R. § 51.912(a)), access charges for such traffic were required to be made equivalent to interstate rates by the effective date of the FCC’s order. TWCIS did not have any access traffic in the Commonwealth in 2011, but it filed a Kentucky access tariff to comply with the FCC’s requirements, which became effective on May 1, 2012.¹ Because there already is parity between TWCIS’s interstate and intrastate access rates, there will not be any further transition with respect to those rates.
