RESPONSE OF COMCAST PHONE OF KENTUCKY, LLC, TO THE
COMMISSION'S MAY 30, 2012, ORDER

COMES NOW Comcast Phone of Kentucky, LLC (“Comcast Phone”) and responds to the Kentucky Public Service Commission Staff’s May 30, 2012, Order in the above docket as follows:

1.

All of Comcast Phone’s voice telecommunication traffic is Voice-Over-Internet-Protocol (“VoIP”). Pursuant to ¶¶ 933-975 of the Federal Communications Commission Order No. 11-161 (the “CC Reform Order”) released November 28, 2011, and 47 CFR § 51.912(a) as promulgated thereby, VoIP-related access charges were required to be made equivalent to interstate rates by the effective date of the ICC Reform Order, which is December 29, 2011. Comcast Phone, on December 14, 2011 filed equivalent tariffs, effective December 29, 2011 in compliance with the ICC Reform Order. Consequently, there is no further transition in Comcast Phone’s rates, as parity has already been accomplished.
