**TWTC's Amendment to 6/10/11 Petition for Confidential Treatment  
re response to AT&T data requests**

tw telecom kentucky, llc ("TWTC"), pursuant to 807 KAR 5:001 § 7 and KRS 61.878(1)(c), hereby submits this amendment to its Petition for Confidential Treatment re response to AT&T data requests, filed June 10, 2011 ("the 6/10/11 Petition"). In the 6/10/11 Petition, TWTC requested that the Commission classify and protect as confidential certain information filed with the Commission as part of TWTC's response to data requests propounded by AT&T in this proceeding on May 2, 2011. This amendment to the 6/10/11 Petition seeks the same confidential treatment for TWTC's supplemental response to AT&T 5/2/11 Data Request #25, and corrects the mistaken omission of Data Request #7 from the ¶ 1 list of responses for which TWTC is seeking confidential treatment. In support of its amendment to the 6/10/11 Petition, TWTC states as follows:

1. TWTC has prepared a supplemental response to AT&T 5/2/11 Data Request #25. One (1) copy of this supplemental response is attached to the original of this amendment to the 6/10/11 Petition. The highlighted portions of the supplemental response would disclose confidential information if filed in the public record, and as a result, TWTC seeks confidential treatment for the information contained therein. Importantly, the reasons articulated in the 6/10/11 Petition for requesting confidential treatment for certain of TWTC's initial responses to

AT&T's 5/2/11 Data Requests apply with equal force to its request for confidentiality for its supplemental response to AT&T 5/2/11 Data Request #25. *See* 6/10/11 Petition ¶¶ 1-5.

2. In the 6/10/11 Petition, TWTC provided the Commission with a list of the responses for which it sought confidential treatment and protection. *See* 6/10/11 Petition ¶ 1. The list failed to include TWTC's response to AT&T 5/2/11 Data Request #7. This was merely an oversight and TWTC seeks to correct that error with this amendment.<sup>1</sup> As such, the following expanded and corrected list identifies the information for which TWTC seeks confidential treatment:

WHEREFORE, TWTC respectfully requests that the Commission classify and protect as confidential the specific information described herein and highlighted in the attachments to the original Petition and this Amended Petition, pursuant to 807 KAR 5:001 § 7 and KRS 61.878(1)(c), and accordingly maintain the information as a nonpublic part of the Commission's file in this proceeding and otherwise prevent public disclosure of the confidential information.
