ATTORNEY GENERAL'S NOTICE OF ERRATA

With

MOTION FOR ENLARGEMENT OF TIME TO FILE ELECTRONIC COPIES OF RESPONSES AND A MOTION FOR ENLARGEMENT OF TIME AND/OR A MOTION FOR DEVIATION FROM FILING HARD COPIES OF HIS RESPONSES

Comes the intervenor, the Attorney General, to submit his notice of errata and motion for enlargement of time to file his electronic responses to the companies' requests for information in the above captioned case and a motion for enlargement of time and/or motion for deviation from filing hard copies of his responses.

STATEMENT OF FACTS

On the days of 24 and 25 October 2012, the Attorney General electronically uploaded his responses to Kentucky Utilities Requests for Information. On 25 October 2012, the Commission assisted the Attorney General in uploading the electronic

responses to Louisville Gas and Electric Company's Requests for Information. The certificates in each pleading indicate that the information was uploaded on 24 October 2012 and that hand-delivered copies were made on 25 October 2012. However, because of insurmountable technical difficulties, the electronic copes were not completed until 25 October and the hard copies have yet to be filed. More particularly, the Attorney General had completed his responses to the companies and began uploading the data at approximately 12:15 P.M. on 24 October.

Having uploaded information in the past, he was confident that the upload could successfully be completed that day. However, within an hour into the process, problems materialized wherein the Attorney General's upload session was either intermittently successful or worse — timed out because the data transfer ceased. Contact was made with the information technology personnel at the Commission, and the Attorney General was informed that other individuals were experiencing problems as well, although the Attorney General did not attempt to ascertain whether the problem was identical in nature¹. At approximately 4:30 P.M., and after continued efforts in uploading, the Attorney General had to abandon his efforts for the day because the Attorney General's main server was shutting down for maintenance.

The uploading of the data recommenced on 25 October at approximately 8:30 A.M. Problems surfaced immediately. Contact was made to Commission staff in an attempt to again trouble shoot the problem which at this point appeared to be isolated

to the Attorney General's uploading of information. Various communications went back and forth between the Attorney General and the Commission staff; however, the uploading of information remained at an incredibly slow rate. The Attorney General continued to upload small files individually unlike some of the prior day's attempts where he had some level of success in sending larger files. Ultimately, he concluded the upload for KU at 11:10 A.M.

Immediately thereafter the Attorney General began his upload of the responses to the LG&E requests. Unfortunately, the process failed completely. Consequently, the Attorney General requested of Commission's information technology staff if it would be acceptable if the Attorney General hand-delivered a disc with the information and have the Commission staff upload the data. Shortly thereafter counsel for the Commission advised the Attorney General that the accommodation could be made. Hence, a disc was delivered and the Commission uploaded the Attorney General's responses to LG&E on 25 October.

While at this time the electronic filing has been completed, neither the hard copy nor a motion for deviation has been filed. With time being of the essence, the Attorney General has focused his efforts entirely in tendering the electronic copy in these responses while trying to timely file his responses to the PSC staff's questions electronically due on 26 October² while secondarily preparing the hard copies

associated with the companies requests for information as well as the hard copies associated with the Commission's requests for information.

NOTICE OF ERRATA

Based on the above history, the Attorney General provides notice that the certificate in the responses to the companies requests for information should be corrected to indicate that the electronic upload occurred on 25 October 2012 and not 24 October 2012. Moreover, the certificate should be changed to the date to be provided once the hard copies have in fact been tendered to the Commission.

MOTION FOR ENLARGEMENT OF TIME TO FILE HARD COPIES AND/OR A MOTION FOR DEVIATION

Based on the above history, the Attorney General moves the Commission to grant him until COB 29 October to either file hard copies or move for a deviation from having to file hard copies in response to the companies' requests for information.
