Louisville Gas and Electric Company (“LG&E”), by counsel, with the concurrence of the Office of the Attorney General and Kentucky Industrial Utility Customers, Inc., hereby moves the Kentucky Public Service Commission (“Commission”) to modify the procedural schedule in this proceeding:

Data requests by Commission Staff and intervenors to other intervenors due	October 15, 2012
Data responses due to KU data requests	October 24, 2012
Data responses due to Commission Staff and other intervenors data requests	October 26, 2012 ¹

No change in the November 5, 2012 date for filing rebuttal testimony is requested.

As grounds for this motion, the electronic case status of this proceeding has raised practical issues of first impression for the Office of the Attorney General and Kentucky Industrial Utility Customers, Inc. with accessing the electronic files and information, causing the need for a short extension of time to prepare and file testimony. The Motion for Modification of

Procedural Schedule is not made for the purpose of unduly delaying the Commission's examination and if granted will not prejudice the Commission's ability to conduct its examination of LG&E's application.
