Dear Mr. DeRouen:

On September 12, 2012, Louisville Gas and Electric Company (“LG&E”) electronically filed a Motion to Deviate From Requirements Governing Filing of Paper Documents in connection with its responses to the Second Set of Data Requests of Kentucky Industrial Utility Customers, Inc. dated August 28, 2012, specifically Item Nos. 44(d), 80 and 83. Because of the voluminous nature of the documents provided in response to KIUC Request Nos. 44 and 83¹, and their extremely large file size, LG&E requested permission to only provide the responses on a DVD that was mailed to all parties and because the response to KIUC Request No. 80 had a very large file size, LG&E requested permission to only provide an original and two copies of the response in paper medium to the Commission and to all other parties on a DVD.

Since filing the information responsive to the Second Set of Data Requests of Kentucky Industrial Utility Customers, Inc. Item Nos. 44(d), 80 and 83 on September 12, 2012, LG&E has been able to break the large single file into multiple parts so that each part can now be uploaded LG&E is uploading these files into the record in this case in the electronic filing portal today. LG&E hereby withdraws its Motion to Deviate only as it relates to electronic submission of these data responses for KIUC Data Request Nos. 2-44 and 2-83. The Motion to Deviate from
