STATUTORY NOTICE

Louisville Gas and Electric Company (“LG&E”), by counsel, informs the Kentucky Public Service Commission (“Commission”) that it is engaged in business as an operating public utility, principally furnishing retail electric and gas service in Jefferson County, Kentucky, and portions of other counties in the surrounding area within Kentucky.

Pursuant to KRS 278.180, LG&E hereby gives notice to the Commission that, on this 29th day of June, 2012, it files herewith its application for adjustment of rates and proposes to adjust its rates in conformity with the tariff sheets (“the revised tariffs”) attached to the application at Tab 7 of the Filing Requirements and made a part hereof by reference.

LG&E proposes to change its existing rates and tariffs for electric and gas service, now on file with and approved by the Commission, by substituting the revised tariff sheets (which are filed as incorporated into the application that is included in this electronic filing) for the corresponding tariff sheets in its existing tariff and by amending the rates and charges or terms and conditions set forth in certain special contracts for electric and gas service.

The proposed revisions or changes to these special contracts are summarized at Tab 7 of the Filing Requirements of the application filed herewith and are made a part hereof by reference.

Notice is further given that the stated effective date for the changes in rates is August 1, 2012, greater than thirty days from the date of filing, pursuant to KRS 278.180 and 807 KAR 5:011. Said effective date is subject to Article I.1.1 of the Settlement Agreement attached to and approved in the September 30, 2010 Order of this Commission in Case No. 2010-00204. Article I.1.1 of the Settlement Agreement expressly permits filing of a base rate case during 2012, but prescribes that no new base rates can take effect before January 1, 2013. LG&E files its applications and provides this notice with the expectation that the Commission will subsequently order the customary five-month suspension of the proposed rates pursuant to KRS 278.190. LG&E therefore requests that the Commission conduct its review during this suspension period and issue an order permitting new base rates to take effect for service rendered on and after January 1, 2013.

Notice to the public of the proposed rates is being given as prescribed in the Commission's regulations (807 KAR 5:051, 807 KAR 5:001, Section 10 (3) and (4), and 807 KAR 5:011, Section 8), by publication in accordance with the Commission's regulations (807 KAR 5:001, Section (1)(4) and 807 KAR 5:011, Section 8(2)(c)), by exhibiting the notice to the public for inspection at the offices of LG&E, 701 South Ninth Street, Louisville, Kentucky, and by posting a complete copy of the application in this case on LG&E's Internet website. A Certificate of Completed Notice will be filed with the Commission in the form recommended by 807 KAR 5:011, Section 15(5).


Additional information required by the Commission's regulations is contained in the application filed herewith and made a part hereof by reference.


