Subject to the Motion for Deviation, the original and two copies of the Petition in paper medium and one copy of the confidential information in paper medium and on CD-ROM are being filed today under separate cover by counsel.

Finally, included in this electronic filing is a Motion for Deviation from the requirement in the Commission's June 22, 2012 Ordering Paragraph 13 that an original and two paper copies of all information electronically filed in the public record also be filed and from the requirement in the Commission's June 22, 2012 Ordering Paragraph 3 that all documents shall be filed with the Commission by uploading an electronic version of the document using the Commission's E-Filing System.
