JOINT MOTION OF KENTUCKY UTILITIES COMPANY AND LOUISVILLE GAS AND ELECTRIC COMPANY FOR LEAVE TO FILE SETTLEMENT AGREEMENT, STIPULATION AND RECOMMENDATION

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (collectively "Companies") hereby move the Public Service Commission ("Commission") for leave to file the attached Settlement Agreement, Stipulation and Recommendation ("Settlement Agreement") and Rate Impact schedule, showing how the revenue allocations recommended in the Settlement Agreement will result in an increase in the average KU residential customer's monthly bill of \$5.16, an increase in the average LG&E residential electric customer's monthly bill of \$4.25, and an increase in the average LG&E gas customer's monthly bill of \$3.30. In support of this Joint Motion, the Companies state that they, the Commission staff, and all other intervenors in these proceedings met at the Commission on November 13, 14, 16, and 19, 2012, to engage in arm's-length negotiations to settle the matters

at issue in these proceedings, if possible. The Settlement Agreement that accompanies this Joint Motion is the product of those negotiations and represents a stipulation and recommendation for the disposition of the matters at issue in these proceedings. The Companies desire to submit the Settlement Agreement into the record of these proceedings for the Commission's consideration and approval to permit a change in base rates for service rendered on and after January 1, 2013.

WHEREFORE, the Companies respectfully move the Commission to grant them leave to file in these proceedings the enclosed Settlement Agreement and Testimony on Settlement.
