 - a) Please provide copies of the reports filed with the Public Service Commission pursuant to 807 KAR 5:006 of the number of disconnections for nonpayment of residential gas and electric customers for years ending June 30, 2009 and 2008.
 - b) The Non-payment Disconnection/Reconnection Report filed by LG&E for year ending June 30, 2007 for gas customers was titled "Gas Customers" in contrast to the reports produced in Response to ACM A-8 which are entitled "Gas Customers Only." (See Attachment A to this Second Request for Information for a copy of 2007 Non-payment Disconnection/Reconnection Report.) Please explain the significance of this difference, including whether different numbers and types of accounts were included under "Gas Customers" and "Gas Customers" Versus "Gas Customers Only" and a description of the types of accounts for each.
 - c) The numbers of disconnections reported on the "Gas Customers" reports for year ending 2007 appear to be higher than for the "Gas Customers Only" reports produced in Response to ACM A-8. Please explain the reasons for these differences in numbers.
 - d) If the "Gas Customers" reports for year ending 2007 included accounts that are not reported under the "Gas Customers Only" reports produced in Response to ACM A-8, please explain where these accounts are now reported.
 - e) Please explain the note "(d)ata includes all residential disconnections including returned checks, diversion, nonpayment of bills and other which may skew the results" which appears on each report produced. Please include in the explanation how the results may be skewed, whether the numbers reported include disconnections for other than nonpayment issues and what types of disconnections are included under "other."

- f) The monthly numbers of disconnections of both gas and electric customers reported for the months of July 2009 through December 2009 reported on the Nonpayment Disconnection/Reconnection Report July 1, 2009 through June 30, 2010 do not agree with figures provided on the attached data response from the previous LG&E rate case, Case No 2009-00549 Response to Second Request for Information of Association of Community Ministries dated March 26, 2010, Response No. A-11. (See Attachment B) Please explain the difference in these numbers reported and which is more accurate.
- A-6. a) Attached are copies of the Non-Payment Disconnection/Reconnection reports filed with the KPSC for years ending June 30, 2008 and 2009.
 - b) The name of the annual Non-Payment Disconnection/Reconnection report for gas customers was changed beginning with the report submitted covering the July 2009 – June 2010 time period. The name was changed to reflect a change in the reporting criteria. The implementation of a new customer information system (CCS) enabled the Company to develop reports with greater detail. Because of the enhanced reporting capabilities of CCS, beginning in July 2009 the Company modified its process for tracking and reporting of customer disconnects and reconnects to separate gas-only customers from combination gas and electric customers. Prior to this change, a combination gas and electric customer whose electric and gas service were disconnected simultaneously, the disconnects were counted under both the electric and gas customer report, thus inflating the actual number of customers disconnected. Currently, a combination customer is only counted on the electric disconnect report. See the attachments to ACM 1-8 for the disconnection/reconnection reports from 2009 to June 30, 2012 and response to July 1. part (a) for disconnection/reconnection from July 1, 2007 through June 30, 2009.
 - c) See the response to part (b).
 - d) See the response to part (b).
 - e) Starting with the July 1, 2009 through June 30, 2010 report, the Note on the reports should have stated "Data includes all residential disconnections excluding return checks, diversion, and other which may skew the results. Examples of disconnections that would be contained within "other" would include manually generated orders to disconnect customers who fail to honor payment commitments and were not disconnected within the internal system timeframe established to complete a system generated order.

f) The numbers of residential disconnections presented in response to ACM 2-11 page 2 of 2 in Case No. 2009-00549 are accurate. Those numbers included customers disconnected for non-payment for any reason. As stated in response to (e) above, the number of disconnections/reconnections reported on the Annual Non-Payment Disconnection/Reconnection Report for the same time periods do not include residential customers disconnected for returned checks, diversion, and other.

- A-13. a) Using 1,010 kilowatt hours and 57ccf of gas (ACM 1-18) and the data response to ACM 1-18(e) each tariff rate can be utilized as shown below to estimate the DSM bill impact as an example. Note that the DSM regulatory proceedings and general rate case regulatory proceedings are separate. As the data provided in response to ACM 1-18(e) was calculated in 2011, the only change resulting from the general rate case on the DSM Mechanism is the reduction of the lost sales component as the reduction in sales is incorporated within the general rate case. Upon the conclusion of the general rate case the Company will file new DSM tariffs to reflect the lower lost sales value in the DSM Mechanism.

b-c) The estimated bill impacts provided in ACM 1-18(e) were calculated under the assumption the tariffs filed under KPSC Case No. 2011-00134 would have taken effect in May 2011. As such the calculations contained assumptions related to program start-up costs, regulatory approval timing, customer participation, rates, and other items. Consequently the data provided remains appropriate as an estimate; however, the actual rates will vary as individual annual budgets for 2012 were adjusted to reflect the forecasted efforts in 2012 realigning the budgets and energy savings to account for the actual approval date in November and DSM rates taking affect January, 2012.

As discussed above in part a. the lost sales component as the reduction in sales is incorporated within the general rate case. Upon the conclusion of the general rate case the Company will file new DSM tariffs to reflect a lower lost sales value in the DSM Mechanism.

Consequently, the DSM line item will change by the amount of lost sales through the end of the test year. Other changes to the DSM amount will remain consistent with the approved case.
