1. In its brief in Case No. 2012-00096, LFUCG stated that Central Division customers should not be required to pay for the costs related to the Northern Division Connection Project.
 - a. State whether the LFUCG continues to maintain this position. Explain.
 - b. If Central Division customers should not be required to pay for the costs related to the Northern Division Connection Project, describe how Kentucky-American should recover the costs of the Northern Division Connection Project.
 - c. Assume that the Commission determined that the costs related to the Northern Division Connection Project should be recovered through a surcharge on Northern Division customers. Describe how such a surcharge should be designed.

Response:

- a. Yes. The costs related to the Northern Division Connection Project ("NDCP") were not reasonably and prudently incurred and should not be borne by the ratepayers. KAW should have disclosed its plan to utilize KRS II for the benefit of Owenton at the time KRS II was being considered by the Commission. The NDCP does not benefit the Central Division and in certain circumstances may harm it. See also the Response of the Attorney General to Commission Staff's Request for Information No. 29 and 30(a) and (b), which LFUCG incorporates herein by reference.
- b. As discussed in the response to part (a), LFUCG does not agree that KAW should be permitted to recover the costs of the NDCP. However, assuming for purposes of the hypothetical that the Commission: (i) grants KAW recovery of some portion of its NDCP costs, and (ii) determines that Central Division customers should not be responsible for any such allowed costs, the only remaining cost recovery option available to KAW would be to recover its allowed NDCP costs solely from Northern Division customers. In that event, Northern Division customers would end up paying higher overall rates for water service than Central Division customers.

- c. LFUGC does not take a formal position as to how a hypothetical NDCP surcharge should be designed. However, in general, using a surcharge to recover allowed NDCP costs would require KAW to: (1) convert its allowed NDCP costs into a Commission-approved annual revenue requirement; and (2) divide that annual revenue requirement by projected Northern Division water sales (gallons) or water revenues. In the case of water sales, the surcharge would apply to a Northern Division customer's total usage. In the case of water revenues, the surcharge would apply to a Northern Division customer's total bill.

2. State whether the LFUCG supports the continued use of uniform rates for Kentucky-American customers, regardless of the division that serves the customer. Explain.

Response:

It depends upon the circumstances. For example, LFUCG does not support the continued use of uniform rates if they will be used as a mechanism to fund the expansion of KAW's services. Each rate proposal regarding uniform rates should be considered on a proposal-by-proposal basis with regard to economic efficiency, equity, rate continuity, and rate understandability, and should be in conformity with KRS 278.030 and 278.170.

3. In its brief in Case No. 2012-00096, LFUCG stated: "Given KAWC's knowledge of the problems with the Owenton system at the time of its acquisition and its failure to mention KRS II as a treatment option at the time it was being approved by the Commission, it would be within the discretion of the Commission to relieve the ratepayers of the burden of paying for this proposal."¹ State LFUCG's factual and legal theory for disallowing rate recovery of the costs related to the Northern Division Connection Project.

Response:

At this time LFUCG is not aware of any facts outside the record of the various PSC cases dealing with the acquisition of Owenton, KRS II and the connection project. 5. Refer to Direct Testimony of William O'Mara at 4. Mr. O'Mara refers to conversations between Kentucky-American officials and LFUCG officials.
 - a. Identify the person or persons who represented Kentucky-American in its discussions with LFUCG regarding Kentucky-American's provision of billing and collection services.
 - b. List the date of each conversation between Kentucky-American officials and LFUCG officials regarding Kentucky-American's provision of billing and collection services and the persons involved in each conversation and describe the contents of each conversation.

Response:

LFUCG objects to this request as it is overly broad and unduly burdensome and it may be better addressed through inquiries to KAW. Without waiving stated objections, and based upon reasonable inquiry, information and belief, and limiting its response to the context of Mr. O'Mara's testimony, LFUCG responds as follows.

- a. The following KAW representatives addressed the issue of billing with LFUCG representatives on one or more occasions: Cheryl Norton, Keith Cartier, Susan Lancho, and John Mark Hack. Additionally, Gerald Reynolds, Richard Bertelson and Lindsey Ingram III represented KAW as counsel during some or all of the discussions involving this issue. Moreover, present during at least one discussion regarding the billing issue were Andrew "Skipper" Martin and Ron Geoghegan, who are employed by McCarthy Strategic Solutions, a firm that may lobby on behalf of KAW.
- b. During the first year of Mayor Gray's term, the provision of billing services was one of multiple issues that were being addressed between KAW and LFUCG, including the transfer of Jacobson Park.

On or about February 17, 2011, John Mark Hack and Cheryl Norton visited the government center and met with Mayor Gray, former Senior Adviser Geoff Reed, Chief of Staff Jamie Emmons, and Law

Commissioner Janet Graham. As part of the meeting, Ms. Norton mentioned that it might be more beneficial for LFUCG to have someone other than KAW to administer its billing process since billing for LFUCG fees is not an area of expertise of KAW.

On or about March 17, 2011, Keith Cartier met with William O'Mara, then Director of Revenue and Jane Driskell, Commissioner of Finance. Mr. Cartier brought collection data on the LFUCG fees showing collection rates were dropping. He suggested that since the change in payment application dictated by the Public Service Commission on or around December 2010, collection rates had eroded and that LFUCG should consider billing these fees in order to avoid any oversight by the Commission. Mr. Cartier also indicated that if LFUCG billed and collected the fees, KAW would be amenable to water shut-off orders from LFUCG for delinquent sewer fees.

During the same general time frame, LFUCG's former Commissioner of Finance, Jane Driskell had a meeting with Skipper Martin and John Mark Hack to discuss the relationship between KAW and LFUCG. It is believed that the billing issue was briefly mentioned. During this general time frame, Jane Driskell also had at least one telephone conversation with Cheryl Norton during which Ms. Driskell was lead to believe that KAW would work with LFUCG on continuing to provide billing services.

On or about May 9, 2011, Mayor Jim Gray, Geoff Reed, Jamie Emmons, Janet Graham, David Barberie, and Richard Moloney met with Cheryl Norton, Gerald Reynolds, Keith Cartier, and Lindsey Ingram to primarily discuss the transfer of Jacobson Park, but the billing agreements were also mentioned.

On or about July 1, 2011, Cheryl Taylor, LFUCG's former Commissioner of Environmental Quality (and a former employee of KAW), lunched with Cheryl Norton and Susan Lancho at their invitation. Several topics were discussed, including the provision of billing services. It is believed that Ms. Norton expressed a desire to meet with Jane Driskell to discuss a transition away from KAW as a biller for LFUCG.

On or about July 13, 2011, Keith Cartier and possibly one other KAW representative (unidentified) met with Jane Driskell and William O'Mara. It is believed that it is during this conversation that KAW indicated that a decision had been made by American Water Works to move away from providing the billing services, but that KAW would work with LFUCG and provide it sufficient time to retain a new entity to provide the services. LFUCG was left with the impression that KAW would be unwilling to reconsider this decision even if LFUCG offered to amend the terms of the agreements to increase the amount of the payments to KAW, and that this transition would take approximately 18 months. LFUCG communicated to KAW that based on preliminary inquiries, the billing transition process would take approximately 18 months and understood that KAW would work with LFUCG on a reasonable transition timeframe.

On or about August 23, 2011, another meeting was held between Jane Driskell, Keith Cartier and William O'Mara at which the same topics as indicated above were also discussed. KAW requested the meeting in order to get an update on LFUCG's progress in finding an alternate billing vendor. LFUCG indicated that it was hiring a consultant to assist it in writing a Request for Proposal to solicit billing and collection vendors.

On or about September 23, 2011, Lindsey Ingram, III, and Rick Bertelson met with David Barberie and indicated that KAW intended to terminate all of the billing agreements on or about March 31, 2012. There were several telephone conversation and e-mail exchanges between these parties related to the form of the termination notices, which were received by LFUCG on or about October 3, 2011.

It is believed around this same time period at least one telephone conversation took place between Jane Driskell and Cheryl Norton, during which Ms. Driskell expressed her surprise and disappointment in the amount of time KAW had provided LFUCG to transition these services to another provider.

On or about September 27, 2011, a consultant employed by LFUCG, Linda Borkosky (with the RFP Company), met with representatives of KAW to begin the process of putting together an RFP for billing services.

On or about January 17, 2012, Cheryl Norton, Keith Cartier, William O'Mara and Jane Driskell met to discuss the transition. KAW requested an update on the progress of LFUCG's billing transition implementation. LFUCG gave an update on the completion of the RFP, its selection of a project manager, and its expectation that it would be selecting a preferred billing and collections vendor in the near future. LFUCG also told KAW that all RFP respondents could not implement by the March 31, 2012 deadline, and requested that KAW extend the March 31, 2012 termination notice. LFUCG understood that at least some of the other American Water Works Companies had agreed to extend the transition period in their respective jurisdictions in order to accommodate the transition by the impacted local government(s).

On or about January 20, 2012 a similar meeting was held between LFUCG's project managers for the billing transition and KAW.

During this same time frame Councilmember Kevin Stinnett had a telephone conversation with Cheryl Norton during which he requested the assistance of KAW in extending the termination dates of the agreements in order to assist LFUCG.

On or around January 26, 2012, David Barberie and Lindsey Ingram had a telephone conversation regarding the form of an extension to the original 180 day termination notices and the LFUCG's process for approval.

On or about May 30, 2012, Mayor Gray, Jamie Emmons, Janet Graham, and Jane Driskell met with Cheryl Norton, Susan Lancho, Skipper Martin and Ron Geoghegan regarding LFUCG's relationship with KAW. During this meeting, the provision of billing services was discussed, including KAW's decision to terminate its billing relationship with LFUCG and the stress put on LFUCG in having to find another billing entity.

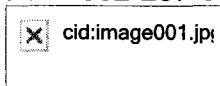

Hi Jane and Bill—I wanted to mention that I had lunch with Cheryl Norton and Susan Lancha from KAW today to discuss a couple of programs on pharmaceuticals collections and watershed educational festivals. We did talk briefly about the issue regarding water billing and Cheryl Norton repeated her commitment to give us time to adjust (aka they won't just pull the rug out from under LFUCG), but if you did not already know it, they are hoping to meet with you soon to review the plan to transition collections from KAW to the city---so I know they are planning on withdrawing their billing services sooner rather than later. You may already be working on a plan, but I just wanted to be sure you know they are expecting to start to see movement in that direction.

The other thing they mentioned that is not project related is that they are seeing a steady drop off in not only collections of WQMF but also the \$4.50 landfill fee. People have figured out we have no clear enforcement strategy so they are not paying anything except sanitary sewer and water bills. This will be a major problem in meeting consent decree requirements if the collections drop off..... we might be looking at adding it to other billing that does have "teeth" to require payment, but I am not sure what is viable.

So, I guess I wanted to inform you about what I heard today and suggest that we meet soon to talk over the strategy---Cheryl Norton mentioned that she plans to set a meeting up with Jane in the next week or so to talk about all this including falling collections----so we can meet either before or after that --- whichever you think is most helpful. Happy New Fiscal Year and 4th of July.

We are advised that fee collections currently conducted on the LFUCG's behalf by Ky American Water Co. (KAWC) will cease on March 31, 2012. This is a full six months earlier than predicted.

The LFUCG User Fee Work Group, headed by Bill O'Mara, intends to meet weekly to develop a new billing service solution.

Taken altogether, KAWC collects roughly \$45 million per year for us across these three funds. Given the gravity of this situation, we seek to brief you on this issue and discuss the preliminary steps taken thusfar, and develop suggested next steps going forward: current process documentation; RFP development; communication to the council; future contract support needs.
