The Attorney General, by and through his Office of Rate Intervention, submits, under seal in a separate envelope marked confidential, one (1) copy of the material in paper medium which identifies by underlining portions of the responses to Items 19 and 23, for which redactions have been made consequent to a request for confidential treatment by the Applicant. These non-redacted responses to the Commission Staff's First Request for Information have been transmitted to the Applicant, Kentucky American Water.

With regard to Items 19 and 23, the OAG responses discuss the Business Transformation Steering Committee meeting minutes. In responding to Item 24(e) of the Commission Staff's Third Request for Information to KAW, the

Company filed a Petition for Confidential Treatment of the material. Consistent with that request, the Attorney General made the redactions.


Upon further review of each response and consideration of the Commission's policy regarding redactions and confidential information, the Attorney General believes that he may have unnecessarily redacted a portion of a sentence in response to Item 19 as well as all of the redacted response to Item 23. The Attorney General anticipates that he will ask for KAW to comment on the redactions, and the redactions are a topic that may be discussed with KAW and Commission Staff at the Informal Conference. If corrective actions are necessary, the Attorney General will file a less redacted response to Item 19 and/or a non-redacted response for Item 23.

Consistent with 807 KAR 5:001 Section 8(7) and Section 13; and Numbered Paragraph 10 and Numbered Paragraph 15 of the Commission's December 17th Order, undersigned certifies that the non-redacted material filed under seal is an otherwise true and accurate copy of each redacted document filed in electronic and paper medium; that the corresponding electronic version of this filing has been transmitted to the Commission; and (in that there are no parties that have been excused by the Commission from participation by electronic means) the filing is in compliance with 807 KAR 5:001 Section 8(7)(c) and Numbered Paragraph 10(c) of the Order of procedure.

WHEREFORE, the Attorney General submits his non-redacted Responses under seal for Items 19 and 23 for the Commission's Staff's First Request for Information to the Attorney General.
