JOINT MOTION OF THE KENTUCKY CABLE TELECOMMUNICATIONS ASSOCIATION AND THE TVA COOPERATIVES FOR PROCEDURAL ORDER

The Kentucky Cable Telecommunications Association ("KCTA") and Hickman-Fulton Counties Rural Electric Cooperative Corporation, Pennyrile Rural Electric Cooperative Cooperation, Tri-County Electric Membership Corporation, Warren Rural Electric Cooperative Corporation, and West Kentucky Rural Electric Cooperative Corporation (collectively the "TVA Cooperatives") jointly move the Kentucky Public Service Commission ("Commission") to issue an order setting the procedure for the next stages of this proceeding.

On April 13, 2015, following the completion of discovery, KCTA filed a Motion for Summary Judgment, requesting the Commission either to grant it summary judgment or to promptly set the matter for hearing. 1. Prior to May 12, 2015, the TVA Cooperatives will make any desired corrections to the deposition transcripts and provide corrected and signed deposition transcripts to counsel for KCTA. On May 12, 2015, KCTA will file the full deposition record in this matter, including

Commission.

2. The TVA Cooperatives will file any motion for summary judgment or other

dispositive motion on or before May 12, 2015.

3. No representative of the TVA Cooperatives or their counsel will take any action

regarding (including any review of) KCTA's pending Motion for Summary Judgment until after

the TVA Cooperatives' Motion for Summary Judgment is filed on May 12, 2015.

4. Any responses to the parties' motions for summary judgment or other dispositive

motions shall be filed on or before June 12, 2015.

5. No further briefing shall be submitted in this matter unless requested by the

Commission.

KCTA and the TVA Cooperatives ask the Commission to enter a procedural order as set

forth in this proposed schedule.
