SUPPLEMENTAL DATA REQUESTS

The Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, submits his supplemental data requests in the above-referenced matter. In accordance with 807 KAR 5:001 Section 8(5)(a) and the Commission's 28 June 2013 Order of procedure, the Attorney General provides this general description of the filing, which consists of the supplemental data requests by the Attorney General to Atmos Energy Corporation (hereinafter "Atmos"). The filing also contains the Attorney General's notice regarding confidential material.

In accordance with the Commission's rules of procedure, 807 KAR 5:001 Section 13, this notice advises the Commission that the Attorney General's supplemental data requests filed herewith includes a separate sealed envelope marked as CONFIDENTIAL, containing an unredacted, CONFIDENTIAL version of data requests AG 2-33, 2-34, 2-36, 2-41, 2-42, 2-43, 2-44, and 2-48, or portion(s) thereof. These specified data requests identify or otherwise references items of information pertaining to tax data, SAP and Accenture and/or other proprietary data for which the petitioner,

Atmos, has sought confidential protection in its petitions filed on 3 June 2013 and 28 August 2013, respectively. On 4 September 2013, the Commission issued an Order granting confidential protection regarding tax data. As of the date of this filing, the Commission has not yet ruled regarding Atmos' petition dated 28 August 2013.

The Attorney General has entered into a non-disclosure agreement with the applicant, agreeing to protect the confidentiality of information for which Atmos deems confidential, and for which it seeks confidential protection from the Public Service Commission by the petition. The Attorney General's filing herewith is consistent with that agreement.

With the exception of the confidential redactions noted above, Pursuant to 807 KAR 5:001 Section 8(7), , undersigned certifies that the electronic versions in portable document format ("PDF") are true and accurate copies of each document filed in paper medium; that the electronic version of the filing has been transmitted to the Commission; and (in that there are no parties that have been excused by the Commission from participation by electronic means) the filing is in compliance with 807 KAR 5:001 Section 8(7)(c) and Numbered Paragraph 10(c) of the Order of procedure.

WHEREFORE, the Attorney General submits his Read1st for the electronic filing and his Notice of Confidentiality.
