# JOINT MOTION OF LOUISVILLE GAS AND ELECTRIC COMPANY AND KENTUCKY UTILITIES COMPANY FOR LEAVE TO WITHDRAW ITS JOINT APPLICATION

Louisville Gas and Electric Company and Kentucky Utilities Company (collectively, the "Companies"), by counsel, hereby respectfully move the Kentucky Public Service Commission ("Commission") for leave to withdraw their application without prejudice. As grounds for their motion, the Companies state, that after further review, they have elected not to proceed with the lump sum payment program as proposed in this proceeding at this time, thereby making the requested relief in the application moot. The Companies continue to believe that such lump sum payment programs benefit customers for the reasons stated in their application and data responses. As a result of further analysis, the Companies have determined that there is a possibility that the proposed plan may initially increase pension expense further than anticipated, thereby creating results that may not fully comport with the traditional analysis for supporting the requested accounting order. Going forward, the Companies will continue to evaluate the lump sum payment as an instrument for managing the risk and volatility of pension plan expenses and expect to be able to do so without triggering the settlement charges which are the subject of this proceeding.
