In its application, KU notified the KPS-C that the revised DSMCRM tariff sheets are proposed to become effective on and after February 16, 2014; however, because KU anticipates the Commission will suspend the proposed changes in the DSMCRM tariff to conduct an investigation of the proposed changes, KU has asked the Commission to approve the proposed changes in its DSM/EE program portfolio and resulting increases in the charges under the DSMCRM mechanism in its DSMCRM tariff to be effective on January 1, 2015.
