LOUISVILLE GAS AND ELECTRIC COMPANY'S AND KENTUCKY UTILITIES COMPANY'S NOTICE OF WITHDRAWAL OF THEIR APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY FOR THE CONSTRUCTION OF GREEN RIVER NGCC AND MOTION FOR RESUMPTION OF THIS PROCEEDING FOR BROWN SOLAR FACILITY

Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (collectively, the "Companies") give notice of their withdrawal of that part of their January 17, 2014 Joint Application which sought a Certificate of Public Convenience and Necessity for the construction of an approximately 700 MW net summer rating natural gas combined cycle combustion turbine facility at KU's Green River Generating Station in Muhlenberg County, Kentucky ("Green River NGCC)"), including a 20-inch natural gas pipeline to serve that facility. The Companies' withdrawal of that part of their Joint Application has no effect on the balance of their Joint Application which seeks a Certificate of Public Convenience and Necessity for the construction of an approximately 10 MW solar photovoltaic facility at KU's E.W. Brown Generating Station in Mercer County, Kentucky ("Brown Solar Facility"). Therefore, the Companies move the Commission for the resumption of this proceeding (which was held in abeyance by the Commission's May 5, 2014 Order) in accordance with the Joint

Application as described herein. The Companies submitted a proposed procedural schedule for the remainder of this case at the August 12, 2014 Informal Conference which is attached to the August 14, 2014 Informal Conference Memorandum.

WHEREFORE, the Companies respectfully request that the Commission treat the Joint Application as amended to remove Green River NGCC and resume the processing of this matter for the Brown Solar Facility project.
