
JOINT MOTION OF

FOR EXTENSION OF TIME

Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”) (collectively, the “Companies”), by counsel, hereby move the Public Service Commission (“Commission”) to enter an order granting the Companies leave to file their responses to the Commission Staff’s Third Request for Information through and until April 30, 2014. The responses are otherwise due by April 28, 2014. As grounds for their joint motion, the Companies state that two additional business days are necessary to complete and prepare the responses due to the press of business and the amount of original work required to compile and organize the requested information. The request for this brief extension of time will not prejudice the Commission or the parties in this proceeding and is not made for the purpose of delaying the Commission’s investigation.

WHEREFORE, Louisville Gas and Electric Company and Kentucky Utilities Company respectfully request the Commission issue an order granting them leave to file their responses to the Commission Staff’s Third Request for Information by April 30, 2014.
