**JOINT MOTION OF**  
**LOUISVILLE GAS AND ELECTRIC COMPANY**  
**AND KENTUCKY UTILITIES COMPANY**  
**TO MODIFY PROCEDURAL SCHEDULE AND**  
**AMEND THEIR MOTION FOR AN INFORMAL CONFERENCE**

Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”) (collectively, the “Companies”) hereby respectfully move the Kentucky Public Service Commission (“Commission”) to modify the procedural schedule in this proceeding by extending the date by which parties must file requests for a public hearing from Monday, June 23, to Monday, July 7. The Companies further respectfully amend their June 12, 2014 Motion for an Informal Conference by requesting an informal conference to be held on June 30, not on June 19 as requested in the Companies’ June 12 Motion.

The Companies so move the Commission recognizing intervenor Sierra Club’s position that a June 19 informal conference would not permit adequate time for the parties to review the Companies’ Rebuttal Testimony, which the Companies filed on June 16. The Companies continue to believe that an informal conference to discuss whether a public hearing is necessary in this proceeding would benefit all parties; one such benefit would be possibly avoiding the need for parties to file request for a public hearing. Therefore, to obtain those benefits while allowing ample time for the parties to review the Companies’ Rebuttal Testimony, the


Companies respectfully move the Commission to schedule an informal conference on June 30 and to extend the deadline to request a public hearing in this proceeding to July 7.
