Kentucky Industrial Utility Customers, Inc. ("KIUC") has reviewed the February 25, 2015 letter filed by Kentucky Utilities Company and Louisville Gas & Electric Company ("the Companies") in this docket stating that the Companies intend to file an application requesting that the Commission approve a DSM surcharge for industrial customers in order to recover the costs of the Cadmus industrial-demand-side-management-and-energy-efficiency-potential study. KIUC has also reviewed the March 11, 2015 letter filed on behalf of the Sierra Club, which argues that the KRS 278.285(3) statutory "opt-out" does not apply to the Cadmus study costs.

KIUC will refrain from taking a position on the Companies' proposal and the Sierra Club's argument at this time. KIUC will weigh in on these, and any other relevant issues, after the Companies file their application.
