# LOUISVILLE GAS AND ELECTRIC COMPANY'S AND KENTUCKY UTILITIES COMPANY'S MOTION TO EXTEND THE DELAY OF ISSUANCE OF PROCEDURAL SCHEDULE

Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (collectively, the "Companies") respectfully request the Commission to extend its delay of the issuance of a procedural schedule in this case until after the August 12, 2014 informal conference in the related Case No. 2014-00002.

By Order of May 5, 2014 in Case No. 2014-00002, the Commission held the procedural schedule in that case in abeyance for a period of 90 days. The Commission's May 5, 2014 Order also scheduled an informal conference in Case No. 2014-00002 for August 7, 2014.

By Order of June 2, 2014 in this case and in the interests of administrative efficiency, the Commission delayed the issuance of a procedural schedule until after the abeyance period in Case No. 2014-00002 ends. However, by Order of July 18, 2014 in

Case No. 2014-0002, the Commission rescheduled the informal conference in that case for August 12, 2104 which is beyond the 90-day abeyance period of the procedural schedule in that case. Out of an abundance of caution and to ensure there are no timing complications in the procedure of this case, the Companies hereby move the Commission to extend its delay of the issuance of a procedural schedule in this case until after the August 12, 2014 informal conference in Case No. 2014-0002. Such an extension will allow the Commission to issue a procedural schedule in this matter that is efficient and consistent with the procedural schedule to be issued in Case No. 2014-00002.

**WHEREFORE**, the Companies respectfully request that the Commission extend its delay in issuing a procedural schedule in this matter until after the August 12, 2104 informal conference in Case No. 2014-00002.
