> Fuel costs related to off-system sales are excluded from the calculation.
> KU's FERC wholesale customers (the munis) are considered native load
> for the purpose of determining the fuel rate on Page 1. However, we
> only apply that rate to retail customers. On Page 5 when determining
> the over/under, we only consider what was collected from retail
> customers. The FERC wholesale customers have their own FAC under
> which we recover the fuel cost associated with energy consumption.
