**MOTION FOR INFORMAL CONFERENCE**



Comes now Duke Energy Kentucky, Inc. ("Duke Energy Kentucky"), by and through counsel, and moves the Commission to schedule an informal conference in this proceeding for the purpose of clarification on the issue of the fuel adjustment clause recovery of energy purchases made within the context of Duke Energy Kentucky's participation in the Day-Ahead and Real-Time Energy Markets administered by PJM Interconnection, L.L.C. In support of said motion, Duke Energy Kentucky notes that the Commission entered an Order granting rehearing on March 6, 2015. There is a significant overlap of issues presented in this case and in Case No. 2014-00226. Thus, in the interest of judicial economy and efficiency, Duke Energy Kentucky suggests that the requested informal conference be held at the same time as any informal conference to be held in Case No. 2014-00226. Duke Energy Kentucky requests that the informal conference be scheduled during the afternoon of April 7, 2015, following the conclusion of the fuel adjustment clause two year review case hearings.

WHEREFORE, on the basis of the foregoing, Duke Energy Kentucky respectfully requests the Commission to schedule an informal conference on the date set forth above.


