Pursuant to ordering paragraphs 3, 5, and 6 of the Commission's Order in this matter dated November 26, 2014, the Joint Applicants, AmeriGas Partners L.P. ("AmeriGas") and Commercial Propane Service LLC ("CPS"), hereby notify the Kentucky Public Service Commission ("Commission") that CPS's acquisition of AmeriGas's utility assets in the Old Bridge Subdivision, Danville, Kentucky, was completed on January 5, 2015; the effective date of the acquisition is January 1, 2015. Included in the electronic filing being made today are a copy of CPS's adoption notice pursuant to 807 KAR 5:011 § 11 and a copy of the new complete tariff in CPS's name (doing business as Bright's Propane Service, Inc.) as required by ordering paragraph 6. The Joint Applicants are filing copies of all closing documents, as well.

It is the Joint Applicants' understanding that the notice above and the filings being made today fulfill the requirements of the November 26, 2014 order in their entirety. As noted in my letter to you dated December 10, 2014, AmeriGas will file the required annual report for Bright's Propane Service, Inc. for calendar year 2014, and CPS will assume responsibility for filing the annual report for the utility beginning with the report for calendar year 2015.

I certify that AmeriGas and CPS's January 5, 2015 electronic filing is a true and accurate copy of the documents being filed in paper medium; that the electronic filing has been transmitted to the Commission on January 5, 2015; that there are currently no parties that the Commission has excused from participation by electronic means in this proceeding; and that the
