Dear Mr. DeRouen:

I am writing to update the Commission on the closing date for the utility transfer the Commission approved in its November 26, 2014 Order in this proceeding. To provide adequate time for closing, the parties presently anticipate the effective date of the transfer will be January 1, 2015. This will result in AmeriGas Partners, L.P. ("AmeriGas") being responsible for filing with the Commission an annual report for the Bright's Propane Service, Inc. utility for the entirety of calendar year 2014. Commercial Propane Service LLC ("CPS") will assume responsibility for all Bright's Propane Service, Inc. utility filings, including filing annual reports with the Commission, for all subsequent calendar years.

Also, after closing the transaction transferring the Bright's Propane Service, Inc. utility to CPS, AmeriGas will file a motion in Case No. 2013-00332, *In the Matter of: an Investigation of the Proposed Abandonment by AmeriGas Partners, L.P. and AmeriGas Propane, L.P. of Utility Service by Bright's Propane Service, Inc. in Old Bridge Subdivision, Boyle County, Kentucky*, seeking to withdraw AmeriGas's abandonment request and asking the Commission to close that case as moot.

The December 10, 2014 electronic filing of this letter is a true and accurate copy of the same document being filed in paper medium. The electronic filing has been transmitted to the Commission on December 10, 2014. There are currently no parties the Commission has excused from participation by electronic means in this proceeding. Finally, an original and one copy in paper medium of this letter are being mailed to the Commission on December 10, 2014.
