Response 12. We are not required to file our final RUS form 7, financial statistical analysis, for December 31, 2014 until March 31, 2015. However our preliminary projection reflects a 1.65 OTIER and 1.72 net TIER for 2014.

Supplemental Response 12. Because information related to calendar year 2014 is now available, Blue Grass Energy states that, for calendar year 2014, its Net TIER was 1.78 and its OTIER was 1.65.

Response 24. The financial data for our RUS form 7 is not required to be filed until March 31, 2015. However we can provide a projection of the data requested. Supplemental Response 24. Except for AG 1-51, Blue Grass Energy has provided supplemental responses to each of the Attorney General's referenced requests. The information requested in AG 1-51 (*i.e.*, a version of Exhibit 17 to Blue Grass Energy's Application that reflects calendar year 2014) remains unavailable at this time, as the relevant statistical comparisons are not released until approximately June of the following calendar year.
