**NOTICE OF WITHDRAWAL OF REQUEST

On February 6, 2015, Sierra Club filed a request to reschedule the hearing set for April 21, 2015 in the above-captioned matter. Sierra Club filed this request after being advised by Commission Staff on February 4, 2015 to promptly file a written notice with the Commission regarding its expert's conflict with the hearing date in order to alert all of the parties to the proceeding of the request.

After reviewing the responses of other parties, including two that identified specific conflicts for their witness or counsel in the weeks following the scheduled hearing date, Sierra Club hereby withdraws its request to reschedule the hearing. In light of the difficulty of rescheduling this hearing, Sierra Club is evaluating various options, such as substitution of its witness or making its witness available to the Commission and parties for cross examination on the first day of the hearing, and will coordinate with the other parties in doing so.
