The Kentucky Cable Telecommunications Association (“KCTA”) submits this Reply in Support of its Motion to Intervene in the above referenced proceeding pursuant to K.R.S. § 278.310 and 807 K.A.R. 5:001, § 4(11).

In its Response to KCTA’s Motion to Intervene, Kentucky Utilities Company (“KU”) states that it does not oppose KCTA’s Motion, but asks that the Commission “ensure that KCTA has standing to intervene.” KU’s Resp. to KCTA’s Mot. to Intervene, at 1.
