# KENTUCKY CABLE TELECOMMUNICATIONS ASSOCIATION'S OPPOSITION TO THE MOTION OF ALICE HOWELL, CARL VOGEL, AND SIERRA CLUB TO RESCHEDULE THE HEARING SET FOR APRIL 21, 2015

The Kentucky Cable Telecommunications Association ("KCTA"), pursuant to the Commission's February 9, 2015 Order, hereby submits its Opposition to the Motion of Alice Howell, Carl Vogel, and Sierra Club (collectively, "the Movants") to reschedule the administrative hearing in the above-captioned matter, currently scheduled for April 21, 2015.

On February 6, the Movants asked the Commission to reschedule the hearing, citing the unavailability of their expert witness the week of April 20. In their motion, the Movants ask the Commission to "postpone the hearing by no more than one week" and state that their counsel and their expert witness are available the week of April 27.
