Enclosed please find Kentucky Utilities Company's and Louisville Gas and Electric Company's (collectively, the "Companies") Joint Motion and Settlement Testimony of Kent W. Blake in the above-referenced cases. Mr. Blake's testimony includes as Exhibit KWB-1 the Settlement Agreement, Stipulation and Recommendation ("Settlement Agreement") reached by the parties to these proceedings. The Settlement Agreement is a unanimous agreement of all the parties to these proceedings who participated in the negotiations; however, the Kentucky Industrial Utility Customers, Inc. will separately file its signature page. Also, as the Lexington-Fayette Urban County Government ("LFUCG") has noted on its signature page, its joining in the Settlement Agreement is subject to ratification by the Urban County Council; ratification is expected when the council next meets on April 30, 2015. The Department of Defense and All Other Federal Executive Agencies ("DoD") was granted intervention in Case No. 2014-00372 but has not participated since then. The Companies' counsel has contacted counsel for DoD and requested DoD to file a statement of position with the Commission by 10:00 am tomorrow, April 21, 2015.
