JOINT MOTION

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E")(collectively the "Companies"), by counsel, move the Kentucky Public Service Commission ("Commission") for leave to file the attached Settlement Testimony of Kent W. Blake, which includes as Exhibit KWB-1 the written settlement agreement of the parties to these proceedings.

As grounds for their motion, the Companies state that the parties to these proceedings along with Commission Staff with one exception attended an informal conference at the Commission's offices on April 16, 17, and 20 to discuss settlement of the issues in these cases. The parties have reached a settlement of all the issues and have documented their understanding in a settlement agreement. The Settlement Testimony of Kent W. Blake describes the settlement process, presents the settlement agreement, summarizes the benefits of the agreement and recommends the Commission accept and approve the settlement agreement for the disposition of

the issues in these cases. The Companies and other parties to these proceedings desire the Commission to receive and consider this evidence at the hearing scheduled for April 21, 2015.

The Settlement Agreement is a unanimous agreement of all the parties to these proceedings; however, the Kentucky Industrial Utility Customers, Inc. will separately file its signature page. Also, as the Lexington-Fayette Urban County Government ("LFUCG") has noted on its signature page, its joining in the Settlement Agreement is subject to ratification by the Urban County Council; ratification is expected when the council next meets on April 30, 2015.¹

WHEREFORE, KU and LG&E request the Commission enter an order granting the Companies leave to file the Settlement Testimony of Kent W. Blake and the written settlement agreement of the parties to these proceedings.
