MOTION TO INTERVENE
OF THE UNITED STATES DEPARTMENT OF DEFENSE AND ALL OTHER
FEDERAL EXECUTIVE AGENCIES

Pursuant to K.R.S. § 278.310 and 807 KAR 5:001. Section 4(11), the United States Department of Defense and all other Federal Executive Agencies (“DoD/FEA”), by and through its legal counsel, hereby requests that it be granted leave to intervene in the above captioned matter, and in support thereof states:

1. DoD/FEA operates Fort Knox in the State of Kentucky,. This installation is a large user of electric power and gas and is served, in part, by Louisville Gas & Electric (“LG&E”). Electric power and natural gas are major expenses for Fort Knox and this proceeding will have a significant impact on DoD/FEA. Accordingly, DoD/FEA’s interests are greatly affected by the decision of the Kentucky Public Service Commission and cannot be adequately represented by any other party. If allowed to intervene, DoD/FEA will present issues and develop facts that will assist the Commission in fully considering this matter without unduly complicating or disrupting the proceedings.
