Using current known saturation levels for space and water heating as cost allocation factors between electric and gas, as appropriate for every measure contained in each residential program shown on page 2 of Appendix B, provide a revised page 2 of Appendix B showing the effect of using this allocation method as opposed to Duke's current methodology based on 63.5 percent gas space heating saturation.
