On November 14, 2014, Kentucky-American Water Company ("Kentucky American Water") filed with the Kentucky Public Service Commission ("PSC") to increase the sewer rates charged to residents of Rockwell Village. Kentucky American Water requested the proposed rates be implemented to all customer classifications in two (2) phases as shown below:

Phase I (Effective for service rendered from December 14, 2014 to December 13, 2015):

The Phase I bill for an average residential customer using 3,000 gallons each month would increase \$2.08 per month, from \$20.75 to \$22.83 or 10%.

The Phase I bill for an average commercial customer using 56,800 gallons each month would increase \$9.83 per month, from \$98.21 to \$108.04 or 10%.

The Phase I bill for an average industrial customer using 16,500 gallons each month would increase \$2.86 per month, from \$28.53 to \$31.39 or 10%.

Phase II (Effective for service rendered on and after December 14, 2015):

The Phase II bill for an average residential customer using 3,000 gallons each month would increase \$2.28 per month, from \$22.83 to \$25.11 or 10%.

The Phase II bill for an average commercial customer using 56,800 gallons each month would increase \$10.79 per month, from \$108.04 to \$118.83 or 10%.

The Phase II bill for an average industrial customer using 16,500 gallons each month would increase \$3.13 per month, from \$31.39 to \$34.52 or 10%.

After both phases are implemented, the bill for an average residential customer using 3,000 gallons each month would increase \$4.36 per month, from \$20.75 to \$25.11 or 21%. After both phases are implemented, the bill for an average commercial customer using 56,800 gallons each month would increase \$20.62 per month, from \$98.21 to \$118.83 or 21%. After both phases are implemented, the bill for an average industrial customer using 16,500 each month would increase \$5.99 per month, from \$28.53 to \$34.52 or 21%. If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the providing of this notice, the Public Service Commission may take final action on the filing.
