Motion For Limited Deviation From 807 KAR 5:001, Section 8

Kentucky Power Company moves the Commission pursuant to 807 KAR 5:001, Section 22 for leave to deviate from the filing requirements of 807 KAR 5:001, Section 8(3) and 807 KAR 5:001, Section 8(12)(a)(2). Both provisions, as amended by Order of the Commission in this case, require Kentucky Power to file the original and three paper copies of all electronically-filed documents within two business days of successfully uploading the data request response.

The Company timely complied with the paper original and copy filing requirement with respect to its responses to the Staff's Second Set of Data Requests, along with the first sets of data requests filed by Kentucky Industrial Utility Customers, Inc. and Kentucky School Boards Association. Because of the volume of the Attorney General's requests and the Company's responses it was not possible to file the paper original and three copies of the Company's responses to all of the Attorney General's First Set of Data Requests within two business days of their electronic filing.

Kentucky Power requests an additional business day, through February 17, 2015, to file the original and three copies of the Company's responses to certain of the Attorney General's First Set of Data Requests. The one-day extension is not made for purposes of delay and Staff, the parties, and the public have access to the electronic filings in the interim.

Wherefore, Kentucky Power respectfully requests an additional business day, through February 17, 2015, to file the original and three copies of the Company's responses to the Attorney General's First Set of Data Requests.
