Pursuant to Order of the Commission dated February 24, 2015, the Attorney General tenders the following Supplemental Data Requests regarding KPCo's responses to AG 1-147 and AG 1-148. KPCo's response to AG 1-147 stated: "The requested copies of each adjusting entry for KPCo, AEP Parent, and AEP Service Corporation that were proposed by KPCo's independent auditors are the property of Deloitte and Touche LLP (Deloitte) and not KPCo, AEP Parent or AEPSC and are part of an exclusive auditor/client relationship. KPCo has no ability to produce the requested information. Subject to certain conditions mandated by Deloitte, Deloitte will make the requested workpapers available for review at their office in Columbus, Ohio." A substantially similar response was provided by KPCo in response to AG 1-148. Pursuant to agreement with counsel for KPCo, and with Deloitte, these materials were made available for the Office of the Attorney General's personal on-site inspection. The following supplemental data requests pertain solely to Deloitte's materials, and are protected by trade secret. Therefore, these questions are redacted to protect the confidentiality of the trade-secret protected items.
