MOTION TO AMEND PROCEDURAL SCHEDULE

Comes now City of Augusta, by and through counsel, and respectfully requests that the Public Service Commission amend the Procedural Schedule which is set forth on the Appendix to the Order entered herein on March 18<sup>th</sup>, 2015, to allow Movant until June 2<sup>nd</sup>, 2015, to complete the filing of the responses to the third request for information made by the Public Service Commission and the Bracken County Water District (Bracken District), which filings are currently scheduled to be made by May 26<sup>th</sup>, 2015. Movant specifically requests that all dates on such Procedural Schedule be extended one week to allow for adequate time between scheduled filings.


As grounds, the City of Augusta states the following reasons, for good cause shown:

1. The City of Augusta's auditor has not provided responses to inquiries presented last week and has, as of this afternoon, instead now suggested that another CPA who assists the City Clerk in preparing the books for the auditor, will need to be consulted in order to obtain the requested information. Such information is needed to finalize both filings.
2. Bracken District has indicated no objections to such Motion, provided that all of such scheduled dates are also extended by one week to allow for adequate time between filing deadlines.

Wherefore, the City of Augusta, for good cause shown, moves for such relief herein requested.
