**MODIFY PROCEDURAL SCHEDULE**


The City of Augusta (“Augusta”) and Bracken County Water District (“Bracken District”) (collectively “Movants”) jointly move for an Order modifying the procedural schedule in this matter to extend the time for submitting written testimony of the parties’ witnesses to August 27, 2015. In support of their motion, the Movants state:

1. The current procedural schedule in this matter was issued on August 14, 2015 and required all parties to submit the written testimony of their witnesses to the Commission no later than August 21, 2015. It thus allowed only seven days to prepare and submit such testimony.
2. Counsel for both parties have other pressing duties that required their attention and are unable to devote their full efforts to ensuring the preparation of the required testimony.
3. Extending the time for submission of written testimony will ensure a thorough and complete presentation of each party’s position and a complete and accurate record, allow for more effective and concise cross-examination, and result in a more productive hearing and a better understanding of the parties’ position by the Commission.
4. The requested extension of time will not require the Commission to revise the dates for the scheduled conference or hearing in this matter.
5. This motion is not made for purposes of delay.

WHEREFORE, Movants requests an Order modifying the current procedural schedule in this matter to permit the parties to submit to the Commission the written testimony of their witnesses no later than August 27, 2015.


