JOINT MOTION TO EXTEND PERIOD FOR SUBMISSION OF BRIEFS

The City of Augusta ("Augusta") and Bracken County Water District ("Bracken District") (collectively "Movants") jointly move for an Order modifying the procedural schedule in this matter to extend the time for submitting written briefs to December 9, 2015. In support of their motion, the Movants state:

1. On September 16, 2015, the Commission ordered that the parties submit their written briefs no later than November 9, 2015.

2. The parties are in settlement discussions and require an additional 30 days to attempt to reach a settlement in this matter.

3. Should the parties reach a settlement in this matter, extending the time for submission of written briefs will permit the parties to avoid unnecessary litigation expenses related to the preparation of written briefs.
