## AT&T KENTUCKY'S MOTION TO HOLD PROCEEDING IN ABEYANCE

BellSouth Telecommunications, LLC d/b/a AT&T Kentucky ("AT&T Kentucky") respectfully moves to hold this proceeding in abeyance to allow time for AT&T Kentucky, CKN, and other interested parties to pursue a possible amicable resolution of the issues raised in this case. In support of this Motion, AT&T Kentucky states as follows.

- 1. AT&T Kentucky filed the Petition that initiated this case, which arose from certain concerns regarding requests from Public Safety Answering Points ("PSAPs") to begin routing AT&T Kentucky's end-users' 911 calls to the Central Kentucky 911 Network ("CKN") rather than directly to the PSAPs.
- 2. AT&T Kentucky submitted written testimony by Mr. J. Scott McPhee, and Mr. Robert Stack filed written testimony on behalf of the Lexington-Fayette Urban County Government ("LFUCG" or "Lexington").
- 3. Based on Mr. Stack's testimony, discovery responses by LFUCG, and confidential settlement discussions, AT&T Kentucky believes an amicable solution to the PSAP requests that led to this proceeding is possible, in which case the issues raised by AT&T Kentucky's Petition could be resolved without requiring a Commission decision.

4. In order to confirm that is so, AT&T Kentucky needs to test the proposed solution with a few county PSAPs to make sure all sides are amenable to it. That will take time. At present, however, AT&T Kentucky's rebuttal testimony would be due this Friday, August 17, 2016.

5. Accordingly, in order to pursue a potential resolution of the case without the need for further testimony, AT&T Kentucky requests that this proceeding be held in abeyance for 120 days. AT&T Kentucky will provide the Commission with a status report after 60 days and 90 days in order to keep the Commission apprised of events and whether it may be likely to reconvene the proceeding.

6. AT&T Kentucky has spoken with counsel for LFUCG (which operates CKN and is the only party that filed testimony responding to AT&T Kentucky, and LFUCG does not oppose holding this proceeding in abeyance as AT&T Kentucky proposes. No party will be prejudiced by holding the proceeding in abeyance and seeking to amicably resolve or moot the issues raised in AT&T Kentucky's Petition.

WHEREFORE, AT&T Kentucky respectfully moves that the procedural schedule be suspended and that this case be held in abeyance for 120 days.
