





**GARRARD COUNTY FISCAL COURT'S
RESPONSE TO VERIFIED PETITION FOR DECLARATORY ORDER**

Comes Garrard County Fiscal Court, Garrard County, Kentucky ("GCFC"), and pursuant to 807 KAR 5:001 Section 3(8), and files the following as its response to BellSouth Telecommunications, Inc.'s, d/b/a AT&T Kentucky ("AT&T Kentucky"), Verified Petition for Declaratory Order. To the extent appropriate and necessary this response shall also serve as a supplemental response of the Central Kentucky 9-1-1 Network (the "Network").

GCFC respectfully requests that this matter be dismissed as the Public Service Commission lacks jurisdiction over the Network. Alternatively, GCFC requests that the relief requested in this matter be denied in its entirety. Finally, in the event that the Public Service Commission finds that the Network is a regulated utility, GCFC reserves the right to join in a request for further relief pursuant to KRS 278.51(2).
