Q-1. Provide the source documents and calculations associated with the Company's response to Item No. 9 of the Commission's initial data requests in this proceeding which support the comparison of the Company's coal pricing to that of neighboring utilities.

A-1. LG&E subscribes to ABB Inc. Ventyx Velocity Suite which is the source data for the comparison of coal cost by utility contained in the response to Item No. 9. Velocity Suite collects data from numerous industry sources and provides market leading industrial software and data to help customers in the power process and mining industries.

The data used in the response to Item No. 9 is from the Ventyx Velocity Suite data file which obtains data from the Form EIA-923 Power Plant Operations Report filed each month by the electric utility industry. The data used in response to Item No. 9 is for the time period June 2014 – May 2015 and is broken down between coal quality equal to and greater than 5.0 lbs. SO₂ and coal quality less than 5.0 lbs. SO₂.

Attached are copies of the data obtained from the Ventyx Velocity suite database. The data was compiled into a total summary for each utility in the comparison for each quality of coal (attachment 1a is equal/greater than 5.0 lbs. SO₂ and attachment 1b is less than 5.0 lbs. SO₂) and was included in the charts on page 2 of 3 and page 3 of 3 of Item No. 9 in the original filing. Also attached are copies of the data for each utility included in the comparison showing the individual suppliers of coal for each utility during the period and coal quality for the comparison in response to Item No. 9.
