In Case No. 2015-00264, Kentucky Utilities Company (“KU”) and Louisville Gas and Electric Company (“LG&E”) (collectively, the “Companies”) filed copies of executed refined coal agreements with the Commission. In light of changes in the volumes of coal utilized at KU’s Ghent generating station and consequently in the amounts of refined coal produced at the refined coal facility hosted at the station, the parties to the agreements have renegotiated certain terms. As such, please find enclosed for filing amended executed agreements for the Ghent generating station that became effective May 27, 2020.


