

Still the Kentucky GOP is not in good financial shape. It reported raising only \$383,000 during the first six months of this year – about a third of what the Democratic Party of Kentucky raised during the same period.

The Kentucky GOP reported \$167,000 on hand as of June 30 with crucial elections for governor and other statewide offices just ahead in November and priority races for the General Assembly ahead in 2016.

Meanwhile, Paul has been struggling a bit on the fundraising front for his presidential campaign, trailing several of the frontrunners among the 17-candidate field of Republicans hoping to be next year's nominee for president. And last week, two key players of a super PAC supporting his presidential campaign were indicted by a federal grand jury on charges that allege they bribed an Iowa state senator in 2012 to switch his endorsement in that year's presidential campaign to Paul's father, Ron Paul.

Richardson said Paul is only the catalyst for an idea that will benefit the state party by making Kentucky relevant in the presidential selection process. "I think it energizes our party, it will engage our people," Richardson said, "But some people always fear change, and others are just damn lazy and worry about the work."

State Sen. Chris Girdler, of Somerset, is among Republicans opposed to the idea, arguing that such a drastic move should not be made to allow Paul to run for two offices at once.

"I'm still unsure what the reasoning for such a drastic move is and do not understand the need for com-

"I just hope I get a hug and a kiss," she said.
