ATTORNEY GENERAL'S MOTION TO RESCHEDULE HEARING
SET FOR MAY 12TH, 2016

The Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, hereby moves the Public Service Commission (Commission) to enter an order rescheduling the hearing date in this matter.

On April 19, 2016, the Commission ordered from the bench an additional hearing date in the above-captioned case in order for the Commission to gather evidence necessary to approve the pending "global settlement" soon to be proffered by the parties. Upon further inspection, the Attorney General recognized the attorney assigned to the case has a standing obligation for the 11th and 12th of May. Due to being a newly sworn member of the bar, Assistant Attorney General Kent Chandler must attend a new lawyer program which runs in conjunction with the KBA Annual Convention, and his failure to complete both days of the required program will result in disbarment. As the primary attorney in this case, and the only attorney in the office with a familiarity of the facts and issues, the absence of Mr. Chandler would place the Attorney General at a

severe disadvantage if the hearing continues on the date authorized by the Commission.


During the proceedings on April 19th, while setting the date for the hearing, the Commission noted that if the date doesn't work, "let us know and we'll work with you." As soon as the Attorney General realized the scheduling issue, he notified both of the other parties in the matter in order to ascertain an agreeable date, so as to facilitate a resolution. The Attorney General contacted counsel for both Water Service and City of Clinton regarding this issue and through that correspondence is able to present dates that work for all parties and seem to comply with the hearing schedule presented on Commission's website. Additionally, both parties have made affirmative statements to the Attorney General that they do object to rescheduling the date of the hearing in order to allow the Attorney General to attend on one of the agreed-upon dates.

WHEREFORE, the Attorney General respectfully requests that the Commission grant his motion to reschedule the hearing date in order to allow him the opportunity to be in attendance during the presentation of his witness in this matter.
