1 I. STATEMENT OF QUALIFICATIONS

2	Q.	Please state your name and business address.
3	A.	My name is Andrea C. Crane and my business address is 199 Ethan Allen Highway, Ridgefield,
4		Connecticut 06877. (Mailing Address: PO Box 810, Georgetown, Connecticut 06829.)
6		
7	Q.	By whom are you employed and in what capacity?
8	A.	I am Vice President of The Columbia Group, Inc., a financial consulting firm that specializes in
9		utility regulation. In this capacity, I analyze rate filings, prepare expert testimony, and undertake
10		various studies relating to utility rates and regulatory policy. I have held several positions of
11		increasing responsibility since I joined The Columbia Group, Inc. in January 1989.
13		
14	Q.	Please summarize your professional experience in the utility industry.

A. Prior to my association with The Columbia Group, Inc., I held the position of Economic Policy and
 Analysis Staff Manager for GTE Service Corporation, from December 1987 to January 1989. From
 June 1982 to September 1987, I was employed by various Bell Atlantic (now Verizon) subsidiaries.
 While at Bell Atlantic, I held assignments in the Product Management, Treasury, and Regulatory
 Departments.

21 Q. Have you previously testified in regulatory proceedings?

1	А.	Yes, since joining The Columbia Group, Inc., I have testified in over 250 regulatory proceedings in
2		the states of Arizona, Arkansas, Connecticut, Delaware, Hawaii, Kansas, Kentucky, Maryland, New
3		Jersey, New Mexico, New York, Oklahoma, Pennsylvania, Rhode Island, South Carolina, Vermont,
4		West Virginia and the District of Columbia. These proceedings involved gas, electric, water,
5		wastewater, telephone, solid waste, cable television, and navigation utilities. A list of dockets in
6		which I have filed testimony is included in Appendix A.

Q. What is your educational background?

A. I received a Masters degree in Business Administration, with a concentration in Finance, from
 Temple University in Philadelphia, Pennsylvania. My undergraduate degree is a B.A. in Chemistry
 from Temple University.

- 15 II. <u>PURPOSE OF TESTIMONY</u>

16 Q. What is the purpose of your testimony?

A. On September 18, 2007, the New Mexico Public Regulation Commission ("NMPRC") initiated this

18 docket to address the following issues:

Whether a five, ten, fifteen, twenty, twenty-five, or thirty year weather normalization
 period should be used to establish rates for natural gas public utilities;

1		> Whether the rule requiring the use of the appropriate weather normalization period in
2		gas utility cases should contain other provisions regarding the use of that
3		normalization period in gas rate cases; and
4		> Whether there are other mechanisms that should be considered by the Commission,
5		such as a weather normalization adjustment ("WNA") mechanism.
7		
8		Pursuant to a procedural schedule established by the NMPRC, Direct Testimony was filed on
9		November 15, 2007 by Public Service Company of New Mexico ("PNM") and by Raton Natural Gas
10		Company ("RNG"). The procedural schedule was extended and Direct Testimony was subsequently
11		filed by Zia Natural Gas Company ("Zia"). The Columbia Group, Inc. was engaged by The State of
12		New Mexico, Office of Attorney General ("Attorney General") to review and analyze the Direct
13		Testimony filed by these parties and to provide Rebuttal Testimony, if appropriate.
15		
16	III.	SUMMARY OF CONCLUSIONS AND RECOMMENDATIONS
17	Q.	What are your conclusions and recommendations regarding the issues in this proceeding?

A. Based on my analysis of the Direct Testimony filed by the parties, on my experience testifying on
 weather normalization issues in utility rate proceedings, and on my review of additional
 documentation, my conclusions and recommendations are as follows:

1		1.	The thirty-year period for determining normal weather is the standard established by the
2			National Oceanic and Atmospheric Association ("NOAA"), an independent government
3			body that is charged with determining the appropriate time period for normal weather.
5		2.	The NMPRC should adopt the NOAA standard as the time frame over which normal weather
6			should be determined for purposes of setting utility rates.
7		3.	The use of the NOAA standard does not preclude the NMPRC from addressing the separate
8			and independent issue of how natural gas usage varies with variations in weather conditions.
10		4.	The NMPRC should reject PNM"s request for establishment of a weather normalization
11			adjustment ("WNA") clause.
12			
13	IV.	DISC	CUSSION OF THE ISSUES
14	Q.	Pleas	e provide a brief summary of the issues in this case?
15	A.	The f	irst issue to be addressed in this case is the time period the NMPRC should utilize for defining
16		norm	al weather for New Mexico gas utilities. Utility rates are established prospectively based on
17		norm	al operating conditions, including normal weather conditions. Therefore, it is important that
18		regula	atory commissions include a weather normalization adjustment that reflects expected usage
19		assun	ning normal weather conditions. The NMPRC has traditionally utilized a period of thirty-
20		years	to determine normal weather. However, in the most recent Public Service Company of New
21		Mexi	co ("PNM") base rate case, the NMPRC deviated from this position and adopted a ten-year

1		NMPRC deviated from this position and adopted a ten-year period to determine pro forma revenues
2		for PNM. That case is currently under appeal.
3		The second issue in this proceeding is whether the rule requiring the use of the appropriate
4		weather normalization period in gas utility rate cases should specify the normalization period to be
5		used. The third issue is whether the NMPRC should adopt other mechanisms, such as a WNA
6		mechanism.
7		
8	Q.	Please summarize the Direct Testimony filed on November 15, 2007 by the utilities.
9	A.	On November 15, 2007, Direct Testimony was filed by PNM and by Raton. PNM filed the Direct
10		Testimony of Dr. David S. Gutzler and John M. Fernald. In his Direct Testimony, Dr. Gutzler
11		recommended the use of a ten-year period for determining normal weather while Mr. Fernald
12		recommended that the NMPRC establish a WNA clause. Dr. Gutzler's recommendation was based
13		on his finding that a ten-year period was the best predictor of weather for the period 2001 to 2007.
14		In spite of Dr. Gutzler's recommendation, PNM witness Fernald recommended against specifying
15		the time period to be used to determine normal weather in the NMPRC's rules.
17		RNG filed the Direct Testimony of David N. Link. In his testimony, Mr. Link recommended
18		that the NMPRC "refrain from ordering RNG to implement additional weather normalization
19		techniquesat this time." ¹

Zia filed the Direct Testimony of Larry W. Loos. Mr. Loos recommended that the NMPRC

1		NMPRC adopt a five-year period for determining normal weather for Zia current rate filing.
2		However, Mr. Loos recommended against one policy for all companies or all rate cases, instead
3		arguing that this issue "should best be evaluated on a case by case basis" ²
4		
5	Q.	Do you agree with PNM's recommendations that the NMPRC utilize a ten-year period for
6		determining normal weather and adopt a WNA clause?
7	A.	No, I do not, for the following reasons:
8		> Dr. Gutzler's recommendation to utilize a ten-year period is contrary to the time period
9		established by NOAA for determining normal weather,
10		> Dr. Gutzler's recommendation assumes that the role of the NMPRC is to predict weather,
11		instead of to establish pro forma revenues based on normal weather conditions;
13		> PNM witness Fernald's recommendation against establishing a specific time period in the
14		NMPRC's rules may result in gaming of the system by utility companies and other parties.
16		> PNM has not provided any testimony regarding the impact of normal weather on natural gas
17		sales.
18		> PNM has not adequately supported its claim for a WNA clause.
19		
20	Q.	Why do you believe that 30-year NOAA data is more appropriate to utilize in developing a

developing a company's weather normalization adjustment than the ten-year period recommended by PNM or the five-year period recommended by Zia?

A. The thirty-year normal has been established by NOAA, the government organization charged with 3 establishing and recording the climatic conditions of the United States. NOAA was formed from the 4 combination of the United States Coast and Geodetic Survey, formed in 1807; the Weather Bureau, 5 formed in 1870; and the Bureau of Commercial Fisheries, formed in 1871. The thirty-year standard 6 is the objective standard, established by the government body responsible for determining normal 7 weather conditions. Moreover, the thirty-year standard is an international standard adopted by the 8 United Nation's World Meteorological Organization ("WMO"). While the thirty-year normal is used 9 for a wide range of applications, it has served as the standard in utility regulation for some time. 10 (See the last page of Appendix B for the NOAA definition of "normal".) 11

13

Q. Do you believe that the use of a NOAA standard is preferable to having the fifty state regulatory commissions set their own standards?

A. Yes, I do. It should not be the role of each regulatory commission to determine "normal" weather. Rather, that determination should be made by the governmental agency and other international bodies that are responsible for tracking, analyzing, and reporting weather statistics. In the United States, that agency is NOAA, which has determined that normal weather should be defined as the arithmetic mean computed over a long period of time. NOAA has further defined the appropriate time period over which to calculate normal weather as three consecutive decades. 1 weather as three consecutive decades.

2

3 Q. Why are longer time periods preferable to shorter ones for weather normalization data?

A. There are a few reasons. First, longer time periods tend to average out weather and temperature 5 extremes much better than shorter periods. Obviously, one particularly cold or warm winter with 6 many or few heating degree days has a much greater effect upon a ten-year average or a five-year 7 average than it does upon a thirty-year average. In fact, a single data point has a 10% impact on a 8 ten-year average, but only a 3.3% impact on a thirty-year average. Therefore, the effect of a single 9 data point is three times greater with a ten-year average than with a thirty-year average. In a five-10 year average, each data point has an even greater impact. Thus, one year of very cold or very hot 11 weather has the ability to significantly skew the results if a five-year average is used. 12

- 14 Second, a shorter time period such as five or ten years may fail to include extreme weather in 15 computing average degree days. It is normal and customary to have a very cold or a very warm 16 winter every so often, and the data base should include these extremes.
- 17

18 Q. Why is it important to have good standard weather data?

A. Utility rates are based upon normal operating conditions. If revenues are based on an accurate,
 consistent and widely accepted standard for normalizing weather, in some years the Company's
 revenues will be less than normal, in some years the Company's revenues will be greater than

1		greater than normal, but over time, the Company's revenues will be normal and the Company will
2		receive the opportunity to earn its fair rate of return. In addition, the use of an accepted objective
3		standard, such as the thirty-year NOAA, ensures consistency from case-to-case.
4		
5	Q.	Are there other factors that lead you to favor the thirty-year NOAA standard over the ten
б		years of data recommended by PNM or the five years of data recommended by Zia?
7	A.	Yes. Among other things, the NOAA standard has a long history of use and acceptance. The use of
8		the NOAA thirty years as "normal" is based upon an international agreement and is commonly used
9		to reflect normal weather conditions in a variety of industries and applications. It is my
10		understanding the NMPRC had traditionally utilized a thirty-year normal until PNM's most recent
11		natural gas case. In addition, I have been advised by counsel that PNM was ordered by the
12		Commission to use a thirty-year normal in Case No. 2662 and that the Commission's decision was
13		upheld by the New Mexico Supreme Court on appeal.

15

16 Q. Is there a statistical reason why a thirty-year normal should be used?

A. Yes, there is. The use of thirty data points has its basis in the central limit theorem, which states that if the sample size has at least thirty data points, then the distribution of sample means is normal, resulting in a normal distribution centered around the mean with a standard deviation that decreases as the sample size increases. Essentially, the population sample of at least thirty data points will result in a bell shaped curve.

1		
2	Q.	Is NOAA examining the possibility of making any changes to the manner in which it
3		determines normal weather?
4	A.	Yes, it is. NOAA has initiated an investigation to address 1) assuring the availability of up-to-date
5		climate normals and 2) assuring the representativeness of a thirty-year average normal given a
6		changing climatic state. This process was initiated in May 2007.
7		The first issue involves the frequency with which NOAA thirty-year normals are updated. In
8		the past, the official NOAA weather normal was based on data during three consecutive decades.
9		Thus, this data was essentially updated only once every ten years. Now that technology has
10		advanced, NOAA is exploring whether it might be reasonable to update the NOAA thirty-year
11		normal weather data more frequently. It should be noted that in PNM's recent natural gas base rate
12		case, I expressed my willingness to utilize the most recent thirty-year data to determine normal
13		weather for the purpose of establishing utility rates. At least part of the rationale for using three
14		consecutive decades of data was the difficulty of updating this data more frequently. Technology has
15		advanced considerably over the past few years, to the point where it is now relatively easy to
16		calculate a new thirty-year normal each year. I understand that NOAA may make more frequent
17		updates to the thirty-year normal available as a result of its current investigation. Therefore, I have
18		no objection to the use of the most recent thirty years to calculate normal weather.

The second issue is whether a basic change from the thirty-year normal should be adopted.
 NOAA has not made any move in this direction at this time. While NOAA has acknowledged that

1		acknowledged that the issue of climate change has been raised by utilities in regulatory proceedings,
2		and while NOAA is exploring the impact of such climate change on the calculation of normal
3		weather, there is no indication that NOAA plans to terminate the use of thirty years as the time
4		period over which to calculate normal weather.
5		
6	Q.	If NOAA changed the methodology used to determine normal weather, and instead adopted
7		some other time period over which to calculate normal weather, would your recommendation
8		change?
9	A.	Yes, it would. As noted above, there are statistical reasons for adopting a time frame of at least
10		thirty years to determine normal weather. However, if NOAA adopted a different standard, then I
11		would recommend a change in the time period used by regulatory commissions, including the
12		NMPRC, to determine normal weather for ratemaking purposes. The important point is that an
13		independent government body should be selecting the time period used to define normal weather.
14		This issue should not be left to be argued over each year in rate cases by parties that have their own
15		motives for suggesting various time periods be used.

Q. Would it be premature for the NMPRC to select a time period of other than thirty-years while NOAA is still investigating this issue?

A. Yes, it would. Since NOAA is the governmental organization charged with determining the
 appropriate time period for normal weather, the NMPRC should not take any actions that would be

1		would be contrary to the NOAA standard at this time. If the NMPRC is inclined to adopt a time
2		period of less than thirty years for determining normal weather, it should wait for the results of the
3		NOAA investigation before adopting any method that would be inconsistent with the current NOAA
4		standard. Rather, if the NMPRC is inclined to adopt a different standard, then it should at least wait
5		for the completion of the current NOAA investigation so that the results of the investigation can be
6		considered by the NMPRC.
7		
8	Q.	Is the purpose of a weather normalization adjustment to predict future weather, as suggested
9		by Dr. Gutzler and Mr. Loos?
10	A.	No, it is not. The purpose of a weather normalization adjustment is not to forecast or predict weather
11		for a particular year. We are regulators, not weather forecasters. The purpose of a weather
12		normalization adjustment is instead to determine what customer usage is likely to be, assuming
13		"normal" weather. Dr. Gutzler's finding that the use of a ten-year normal was a better predictor of
14		the weather in 2001-2007 does not provide any meaningful information about normal weather and
15		therefore the premise of his analysis is flawed. Mr. Loos' argument that a five-year average is the
16		best predictor of actual weather in the first year of new rates is similarly flawed.
18		The regulator is attempting to determine, on a prospective basis, what a "normal" period
19		of operating results will be. One of the components of this determination is normal weather.
20		The regulator is not trying to predict weather, or to make a company indifferent to weather, but

rather to set rates prospectively that are normalized for weather. In some years a utility will have

- weather. In some years a utility will have colder than normal weather and in some years it will
 have warmer than normal weather. But over time, weather will be normal.
- 3

4

Q. Are there flaws in the predictive analyses presented by Dr. Gutzler and Mr. Loos?

5 A. Yes, there are. As noted above, the purpose of a weather normalization adjustment is not to predict the weather in subsequent years, but rather to determine a normalized level of utility sales 6 7 based on the assumption that the weather will be normal. However, even if one assumes that the goal of the weather normalization adjustment is to predict weather conditions, which it is not, 8 then Dr. Gutzler's analysis is still flawed. One of the problems with Dr. Gutzler's analysis is that 9 he considered the period 2001-2007 as one period for purposes of determining the best predictor. 10 . Dr. Gutzler's use of the average 2001-2007 period masks results that occurred in specific 11 years. As shown in the response to AG 1-3 which contains Dr. Gutzler's workpapers, Dr. 12 Gutzler attempted to predict 2001-2007 degree days at six NOAA sites in New Mexico. He 13 14 concluded that ten years was the best predictor of actual degree days from 2001-2007. However, 15 if he had examined seven individual years for each site, instead of the average results over the seven year period, a different pattern emerges. Of the forty-two data points (seven years times 16 six sites), the thirty-year normal is the best predictor in 10 of the 42 cases, or 23.8%. The ten-17 year normal is the best predictor in 9 cases. The thirty-year normal is a more accurate predictor 18 of the following: 2001 and 2007 weather in Albuquerque, 2007 weather in El Morro National 19 Monument, 2007 weather at Ft. Bayard, 2001, 2005, and 2007 weather in Roswell, and 2001, 20

1		2007 weather in Roswell, and 2001, 2005, and 2007 weather in Santa Fe. Although the purpose
2		of the weather normalization is not to predict the weather, it is interesting to note that if one was
3		attempting to predict weather from 2001 to 2007, then the thirty-year normal would have served
4		as a slightly better predictor than the ten-year normal recommended by Dr. Gutzler.
6		
7	Q.	Does an examination of the thirty-year weather data suggest that it continues to be
8		appropriate for use in determining normal weather?
9	A.	Yes. In Appendix B, I have provided data produced by NOAA showing the actual temperature
10		in New Mexico during the past thirty years for the winter period, which is defined by NOAA as
11		December to February, as well as the thirty-year average for the winter period. I have also
12		provided data on the individual months of December to February.
14		As shown by this data, the thirty-year period continues to be a reasonable average to use
15		in determining normal weather. The winter period in New Mexico was colder than the average
16		in two of the past five years, and in five of the last ten years. While the 2007-2008 winter period
17		ranked approximately in the middle of the data, ranking fourteenth out of thirty years for cold
18		weather, it was still colder than the thirty-year average. It is interesting to note that the longest
19		stretch of above or below average winter temperatures occurred from 1987 to 1992, when New

Mexico experienced six straight years of colder than normal weather. This period demonstrates 20 the problems with using a relatively short period of time, such as five or ten years, to determine 21

1	a relatively short period of time, such as five or ten years, to determine normal weather. If a five-
2	year or ten-year period that included 1987 to 1992 had been used to set rates, it is likely that
3	utility rates would have reflected an artificially high level of pro forma sales. By using a thirty-
4	year period, the impact of any one year is mitigated and the result is more representative of
5	weather over a longer period of time. Since weather conditions change slowly, the thirty-year
6	average provides a good balance between the need to mitigate the impact of any single year and
7	the need to reflect long-term changes that may occur in climatic conditions.

9

Q. Will PNM's recommendation that no specific time period be included in the NMPRC's rules result in gaming of the system?

Yes, it may. Dr. Gutzler found that a ten-year period is the "best choice of normalization A. 12 period." Nevertheless it is PNM's recommendation that the NMPRC's rules provide for 13 "flexibility in allowing parties to select an alternative period of time over which weather results 14 would be used...."³ This "flexibility" will result in all parties arguing from case-to-case that the 15 NMPRC should choose a time period that provides the best result for that particular party. The 16 thirty-year period for determining what constitutes normal weather was not defined by me, or by 17 the Attorney General. Rather, it was defined by the United States Government organization that 18 is responsible for defining normal weather, i.e., NOAA. Once the NMPRC provides for 19 "flexibility" from case-to-case, then all parties will have an incentive to promote the time period 20

1	will have an incentive to promote the time period that results in the best result for their particular
2	constituency in each particular case. For example, while PNM generally supports a ten-year
3	period for determining normal weather, one or two particularly cold winters could make the use
4	of a ten-year average significantly less attractive to the Company. Under PNM's proposal, it
5	would therefore have the flexibility to argue against a ten-year average when that average would
6	result in a smaller pro forma revenue adjustment.

Mr. Loos, on behalf of Zia, also proposes that the Company retain the flexibility to 8 change the period used to determine normal weather. Mr. Loos recommends the use of five-9 years of data "at least for the purpose of Zia's upcoming rate case...".⁴ He recommends, 10 however, that the issue "should best be evaluated on a case by case basis, based on the most 11 recent conditions for the weather stations relevant to the utility." While he doesn't address how 12 the "most recent conditions" would factor into the selection of the time period to use for normal 13 weather in future cases, one can surmise that Zia would select the time period that would most 14 benefit the utility. 15

16

17 Q. Should the time period used to determine normal weather be included in an NMPRC rule?

A. Yes, it should. In order to ensure consistency from case to case, and to prevent any party from gaming the system, the NMPRC should formalize the time period used to determine normal weather.

1		normal weather. It is my recommendation that the NMPRC adopt a thirty-year normal. However,
2		even if the NMPRC finds that a different time period is appropriate, it should formalize its finding
3		through a rule that applies to all natural gas utilities in all gas utility rate proceedings.
5		
6	Q.	Isn't it possible that weather patterns do change over time?
7	A.	Yes, it is. However, permanent changes in weather patterns are likely to take place over a long
8		period of time. NOAA has determined that a period of thirty years represents normal weather. To
9		the extent weather patterns do exhibit a permanent change over time, such changes will be reflected
10		in the thirty-year NOAA data. The NMPRC should not confuse the determination of "normal"
11		weather with the issue of how customers will react to variations from normal weather. The fact that
12		gas prices have risen, there is better communication with customers, and energy efficiency incentives
13		are offered has no impact on the weather, or on the definition of normal weather. But, these factors
14		do impact how customers respond to deviations from normal weather. Weather is based on
15		climatological patterns and customers have virtually no impact on these weather patterns, at least not
16		over the thirty-year period that is defined as constituting normal weather.

However, the NMPRC should be mindful of the difference between changes in weather
 patterns over time and changes in usage patterns over time. The two are not the same. While
 NOAA uses a thirty-year period to determine normal degree days, NOAA is not involved in
 forecasting how natural gas sales are likely to be impacted due to variations in degree days. For

1 in degree days. For example, assume that the thirty-year normal results in total degree days for the PNM service territory of 5,500 degree days. A separate but related question, and one that has not 2 been addressed by PNM, is how customer usage changes with changes in degree days. Due to 3 conservation efforts, more efficient appliances, price elasticity, and other factors, it is entirely 4 possible that the impact of variations in degree days is different in 2007 than it was in 1967. It 5 6 should be noted that neither PNM's Direct Testimony nor Zia's Direct Testimony addressed the 7 impact of variations in degree days on customer usage, but that issue is an important one that can and should be addressed in a base rate case. My recommendation that the NMPRC adopt a thirty-year 8 degree day standard does not prevent the utility or other parties from presenting arguments regarding 9 the impact of weather variations on natural gas usage. By adopting a thirty-year weather standard, 10 the NMPRC is not precluding any party from providing evidence demonstrating the impact of 11 various weather changes on natural gas usage in a gas base rate case. 12

Neither Dr. Gutzler nor Mr. Fernald has presented any evidence in this case regarding the impact of weather changes on gas sales. Instead, PNM's Direct Testimony focused on which time period was preferable for predicting the average weather from 2001-2007. Similarly, Mr. Loos also failed to address the impact of weather variations on gas usage. Instead, Mr. Loos argues that the five-year average best predicts actual weather in the first year of new rates. Mr. Loos fails to recognize, however, that the role of the regulator is to determine a representative usage level based on normal weather, not to predict the weather for any particular period.

1 2 **Q**. Should the NMPRC adopt a weather normalization clause, as proposed by Mr. Fernald? No, it should not. PNM has not provided any evidence that a weather normalization adjustment is A. 4 required by the gas utility. The Company is already guaranteed recovery of its gas costs on a dollar 5 for dollar basis, which significantly reduces the risk to shareholders. PNM's request for a WNA 6 clause is an attempt to transfer much of the remaining risk from the Company's shareholders to its 7 ratepayers. Moreover, the WNC as proposed by PNM would be regional, creating an administrative 8 nightmare for the NMPRC and for the other parties that have the responsibility to review periodic 9 filings. Accordingly, I recommend that the WNC mechanism proposed by PNM be rejected. 10
