**JOINT MOTION FOR LEAVE TO FILE SETTLEMENT TESTIMONY**


Kentucky Utilities Company (“KU”) and Louisville Gas and Electric Company (“LG&E”)(collectively the “Companies”), by counsel, move the Kentucky Public Service Commission (“Commission”) for leave to file the attached Settlement Testimony of Robert M. Conroy, which includes as Exhibit RMC-1 the written settlement agreement of the parties to these proceedings. The Kentucky Industrial Utilities Customers, Inc. executed the agreement by counsel on June 13, 2016; the Office of Rate Intervention of the Attorney General of the Commonwealth of Kentucky has recommended to the Attorney General that he approve the settlement agreement, whose approval is anticipated on June 14, 2016.

As grounds for their motion, the Companies state that the parties to these proceedings along with Commission Staff attended an informal conference at the Commission's offices on June 9, 2016 to discuss settlement of the issues in these cases. Subject to the Attorney General's anticipated approval, the parties have reached a settlement of all the issues and have documented their understanding in a written unanimous settlement agreement. The Settlement Testimony of Robert M. Conroy describes the settlement process, presents the settlement agreement, summarizes the benefits of the agreement and recommends the Commission accept and approve the settlement agreement for the disposition of the issues in these cases. The Companies and other parties to these proceedings desire the Commission to receive and consider this evidence at the hearing scheduled for June 14, 2016.

**WHEREFORE**, Kentucky Utilities Company and Louisville Gas and Electric Company request the Commission enter an order granting the Companies leave to file the Settlement Testimony of Robert M. Conroy and the written settlement agreement of the parties to these proceedings.
