#### Dear Executive Director:

We are legal counsel to West Kentucky Rural Telephone Cooperative Corporation, Inc. d/b/a West Kentucky and Tennessee Telephone Cooperative ("WK&T"). Pursuant to the Commission's February 21, 2022 Order in Case No. 2016-00059 (the "Order"), WK&T, through counsel, hereby files its letter detailing the information requested by the Commission in the Order.

As of the date of filing this letter, WK&T offers or anticipates offering four broadband only service plans, all with no data caps, to Kentucky Customers under the Federal Communications Commission's Affordable Connectivity Program. As of the date of filing of this letter, all Affordable Connectivity Program service plans that are or will be available to Kentucky Lifeline Customers and the cost of the service plans that are or will be eligible for the Affordable Connectivity Program are as follows:

For eligible Lifeline service plans, and consistent with the Order, WK&T will continue to seek reimbursement from federal sources first and from the KUSF last. Because WK&T does not provide bundled voice and broadband service plans to Lifeline customers, no reimbursement from the KUSF will be sought for WK&T's Affordable Connectivity Program eligible service offerings.

Consistent with the Order, the Lifeline and Affordable Connectivity Program credits will be applied by WK&T in the following manner:
