Dear Executive Director:

We are legal counsel to Ballard Rural Telephone Cooperative Corporation, Inc. d/b/a BTC ("BTC"). Pursuant to the Commission's July 22, 2021 Order in Case No. 2016-00059 (the "Order"), BTC, through counsel, hereby files its letter detailing the information requested by the Commission in the Order.

BTC offers three broadband only service plans, all with no data caps, to Kentucky customers under the Federal Communications Commission's Emergency Broadband Benefit ("EBB") Program. For the EBB eligible broadband only plans offered to Lifeline customers, BTC does not seek reimbursement from the KUSF. The broadband only service offerings that are eligible for the EBB program, the cost of those service offerings, and a description of how the federal Lifeline and EBB support will be applied to those service offerings is set forth in the chart below.

In addition to its broadband only service plans, BTC also offers three add-on broadband plans to Kentucky Lifeline customers who are enrolled in a Lifeline eligible telephone plan with BTC. For those Lifeline customers who choose to add broadband services to their telephone plan, BTC applies the EBB credit to the cost of the add-on broadband services, and seeks federal and state Lifeline support for the eligible telephone service. The add-on broadband service offerings that are eligible for EBB and available to Kentucky Lifeline customers enrolled in a telephone service with BTC, the cost of those service offerings, and a description of how the EBB, federal and state Lifeline support will be applied to eligible plans is set forth in the chart below.
